Sungguh, dia tidak menyukai orang-orang zalim(40). Tetapi orang-orang yang

membela diri setelah dizalimi, tidak ada satu dosapun terhadap mereka (41). Sesungguhnya kesalahan hanya ada pada orang-orang yang berbuat zalim kepada manusia dan melampaui batas di bumi tanpa (mengindahkan) kebenaran. Mereka itu mendapat siksa yang pedih (42).

More than that, the impact of the invasion and revolution is the changing social structure of Afghan society which creates a new conflict in this novel. In this novel, it is also told about the sin of a child whose ego and fesr in helping his best friend make him wallow in regret for the rest of his life. The story present in this novel is so emotional, the story of moral tragedy, friendship, betrayal and loyalty is neatly packaged in this novel.

A blush, red like henna, bloomed on her cheeks."(Khaled Hosseini:157). This affection is to be required understand to each other in all aspect of human life such as a young womens and a young mans having love, parentand son, sisters and brothers, mother and son and than affection friends each other and between host and maid servant.
- 8. Kind and friendly, "well, everyone in my school knows what it means," I said. "let's see. 'Inbecile.' It means, intelligent. I'll use it in a sentence for you.
